

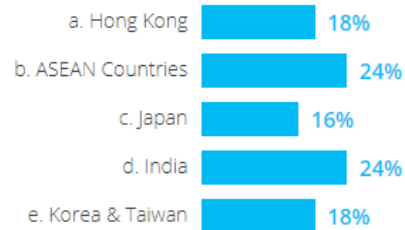

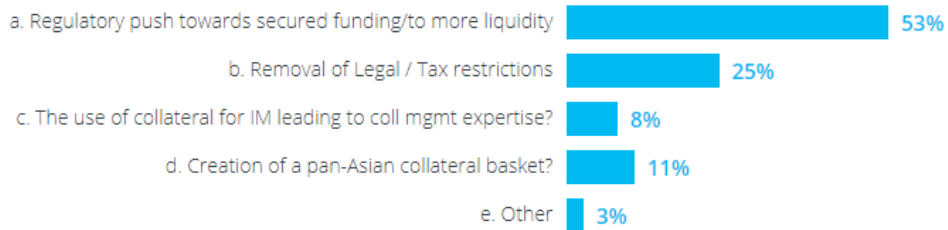


Global Poll #2

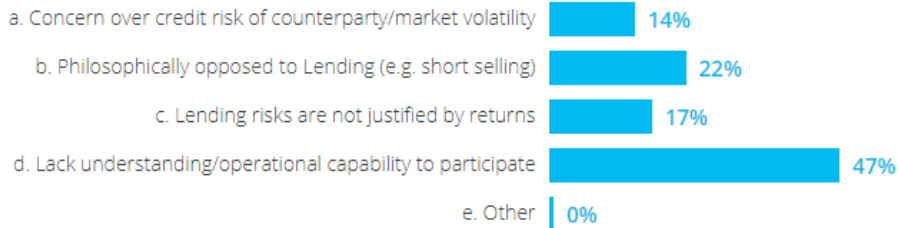

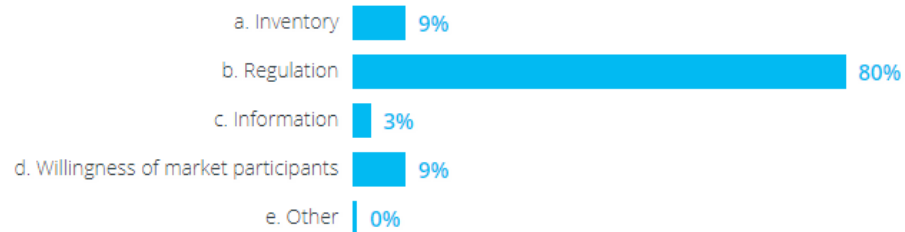

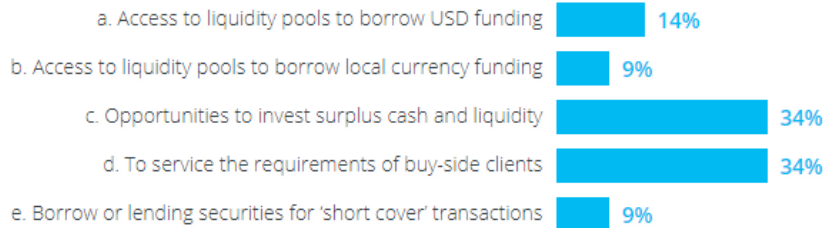

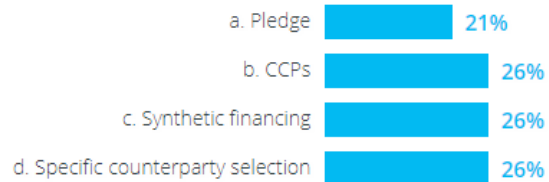

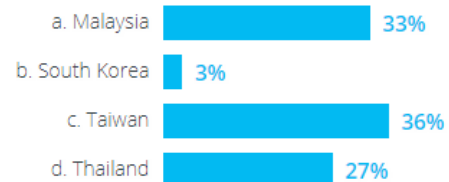

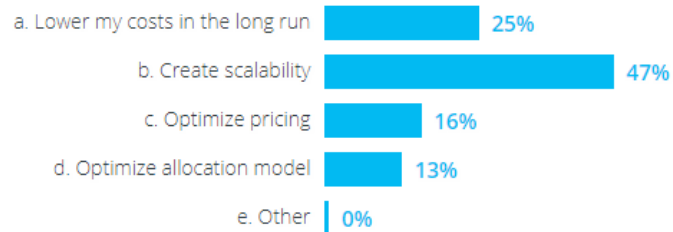

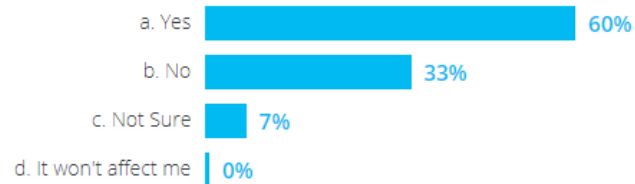

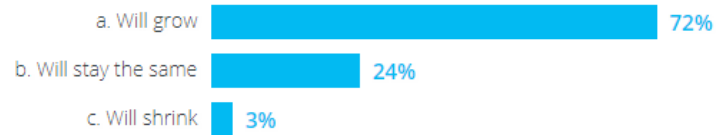

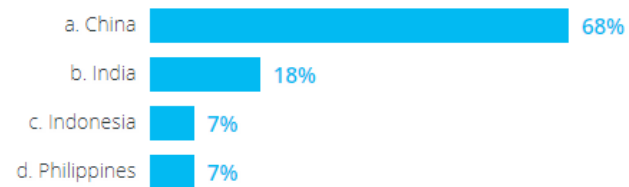

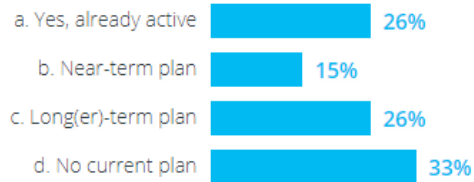

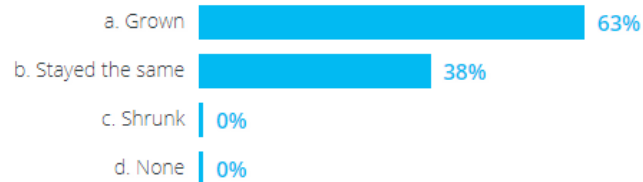

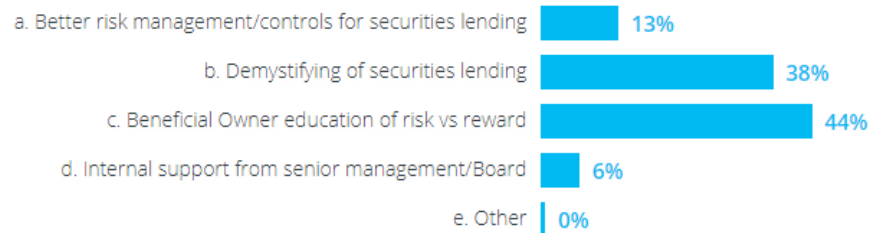

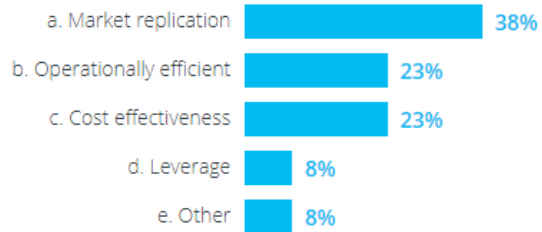
